

# Preventing and Treating Harms of the Opioid Crisis




Opioid overdoses and infectious harms from drug use can be prevented and treated through access to important resources such as:

- Naloxone to reverse overdoses
- Medication-assisted treatment
- Substance use treatment services
- Syringe services programs
- Hepatitis C testing and treatment
- HIV prevention services
- Vaccination services

All of these resources are available in Wisconsin, but some areas have fewer resources. The Wisconsin Department of Health Services (DHS) is working together with community partners to improve access to these life-saving resources in the areas of Wisconsin that need them the most, shown in the map on the left in gray.

# Gov. Tony Evers signs 4 bills in La Crosse to help people in recovery March 4, 2020 Acts 119,120,121, & 122 – Heroin, Opioid Prevention and Education or HOPE program

Rep Jill Billings worked with Rep John Nygren to get the bills passed. The new laws will:

- Allow county jails to enter agreements to obtain naloxone and training on how to administer it
- Prevents state employees from being discriminated for using a controlled substance as prescribed
- Creates a registry of recovery residences in order for residences to receive referrals and funds from the state. Also requires Medicaid to reimburse certain peer-recovery coach services
- Continue the WI PDMP for another
   5 years



### Alliance to HEAL - Goals



1. Limit the supply of opioids in our community



2. Raise awareness of the risk of opioid use disorder



3. Reduce opioid-related addiction, deaths, and crime in our communities



4. Create a readily accessible, coordinated, systemic response that increases treatment capacity and enhances the prevention, treatment, and recovery continuum


### Heroin use is part of a larger substance abuse problem.

People who are addicted to...










# Work Group #1 Improve Prescribing Practices

- ✓ By July 1, 2019, Gundersen Health System and Mayo Clinic Health System will develop a system for tracking, analyzing, and sharing data around opioid prescriptions
- ✓ Implement consistent CDC Opioid Prescribing Guidelines
- ✓ Fall Conference for Primary Care Providers, RN's, Counselors, Mental Health, & Educators Planned

#### Measures:

- 1. Decrease the total number of opioid prescriptions by 20% by 1-1-20
- 2. Decrease the number of total opioid pills per Rx by 20% by 1-1-20




# Group 7 Enhance Capacity of MAT (Medicated Assisted Treatment) AIM: Increase number of individual in Medicated Assisted Treatment

All MAT providers are meeting together and collaborating to improve access to treatment, including the jail



# Diversion of Opioids

#### **Drug Pick-up Program**

- ✓ Sheriff's Office partnership with ADRC
- ✓ Deputy ride along with Senior Nutrition Program meal delivery to pick-up unused medications
- ✓ Drug Take Back Day Events for communities

#### Measures:

- 1. # of local disposal methods/options
- 2. Pounds collected from disposal methods/options
- 3. # of households/individuals contacted/participating
- 4. # of opioid drug-related charges
- 5. # of pounds of opioids seized by law enforcement

Our Drug Take Back Days collected over 2,300lbs of medications & <u>over 24,550lbs</u> were collected from GHS, MCH, & Walgreens drop boxes in La Crosse County!

## GROUP 3 Alternative Pain Management

- ✓ Developed an asset list of agencies who provide alternative pain management
- ✓ Developed PSAs with WXOW to increase the public's awareness of non opioid therapies
- ✓ Work with healthcare systems with suggested messaging to share with their provider networks on options
- ✓ Special 30 Minutes Series on Alliance to HEAL on WXOW
- ✓ Currently exploring a support group for pain

# 5. Navigation & Assessment

Focused on creating positions to help with the navigation to and through treatment and recovery services.

<u>Recovery Systems Coordinator</u> who will be responsive to individuals when they are ready to seek support and connect them to the systems and services that they qualify for in real time and

<u>Recovery Systems Navigator</u> who will work alongside individuals who might have a delay in receiving support services, waiting on accessing treatment, or may not qualify for some of the supportive programs in the community.

# The need for a recovery center and residential housing in La Crosse County

22 Drug Overdose Deaths in La Crosse County in 2019

No inpatient treatment center in the region (LE Phillips in Chippewa Falls and Tellurian in Madison)


<3% of La Crosse County Residents are served by LE Phillips and no clients are served by Tellurian

No residential services beyond Gundersen's Unity Housing

Average reported wait time for help was >30 days (A2H survey in spring 2019 from 102 clients)

The need for improved efficiencies among both healthcare and the County services

In 2017, the jail had 5,700 bookings and 2,361 went through Drug or Alcohol detox protocol

# Narcan and Needles – Group Nine



- Increase number of improperly disposed needles collected with 7 additional outdoor sharps boxes (9 total) Collected 1,620 lbs. of sharps/needles in 2019)
- Found vendor for pickup and disposal (no cost)
- Narcan to all patients with history of opioid use disorder, history of OD, higher opioid dosages, and or current benzodiazepine use
- Offer Narcan to all patients discharged from both healthcare ER Department after an opioid overdose
- Crisis team follows up with all patients after discharged from ER after an opioid OD



# Policy #10

Research, recommend, develop policies that impact the opioid epidemic and those seeking treatment and recovery services

  - Cost of/access to pain alternatives
